Codes Officer Cesario has asked the Board to establish a price for the truss placards. Patty Bikowsky made the motion to charge \$15.00 for the stickers and \$ 25.00 for the plates. Brad Dixon 2nd it, all in favor so moved.

Patty Bikowsky made the motion to advertise for bids for the judges/board bench construction, Brad Dixon 2nd it, all in favor so moved.

Deputy Supervisor Lundrigan presented the following resolutions to the board for their consideration:

17-10 to move monies in the amount of \$27,000 from incorrect transfer back to Aquatic Growth NBT money market and into the correct money market account. Brad Dixon made the motion to adopt the resolution, Patty Bikowsky 2nd it, roll call vote 3 votes yes.

17-11 to move \$189.36 from the Aquatic Growth Money market and into the town checking account for March's bills. Patty Bikowsky made the motion to adopt the resolution, Brad Dixon 2nd it, roll call vote, 3 votes yes.

Bills in the General Account in the amount of \$ 22,576.66 and bills in the Highway Account in the amount of \$ 19,083.35 for a total of \$ 41,660.01 were audited and approved for payment with a motion made by Patty Bikowsky, 2nd by Brad Dixon, all in favor, so moved.

At 7:45PM Patty Bikowsky made the motion to adjourn, Brad Dixon 2nd it, all in favor, so moved.
