18-16 to adopt the land use regulations as Local Law #1 for 2018. Jim Lundrigan made the motion to adopt the resolution, Brad Dixon 2nd it, roll call vote, 4 votes yes.

Bills in the General Account in the amount of \$ 24,784.87 and bills in the Highway Account in the amount of \$ 40,383.80 for a total of \$ 65,168.67 were audited and approved for payment with a motion made by Patty Bikowsky, 2nd by Brad Dixon, all in favor, so moved.
